SECTION 1 SAFETY PRECAUTIONS

1.0 Introduction

This section is the starting point for establishing habitual precautions for safe operation of the Bronco. This manual is your guide in developing a daily routine that focuses on safety and proper maintenance prior to each use. A maintenance program must be established and conducted by a qualified person to ensure the Bronco is in safe working condition before it is operated.

Before operating the Bronco, the operator must:

- 1. Read, understand, and obey the operating instructions and safety rules in the manual.
- 2. Obey all labels, warnings, and instructions located on the Bronco.
- 3. Be sure that all occupants of the all-terrain scaffold wear appropriate personal protective equipment (PPE) for the conditions.

If there are any questions regarding safety, training, maintenance, inspection, application, or operation of the Bronco, please contact ReechCraft.



FAILURE TO COMPLY WITH THE SAFETY PRECAUTIONS LISTED IN THIS MANUAL COULD RESULT IN SCAFFOLD DAMAGE, PROPERTY DAMAGE, PERSONAL INJURY, OR DEATH.

1.1 Pre-operation

Operator Preparedness

- Do not operate the Bronco until the operator has read and fully comprehends this Operator's Safety Manual.
- Only competent personnel may operate the Bronco.
- Read, fully comprehend, and obey all dangers, warnings, cautions, and operating instructions on the Bronco and in this manual.
- Only use this Bronco in a manner which is within the scope of the intended application set by ReechCraft.
- All operating personnel must be familiar with the emergency procedures and controls specified in this manual.
- All operating personnel must read, comprehend, and obey all applicable employer, local, and governmental regulations as they pertain to the safe operation of the Bronco.

Worksite Inspection

 The operator is to take measures to identify and avoid all hazards in the work area that will affect the safe operation of the Bronco.

Bronco Inspection

- Before operation, perform walk-around inspections and function checks. Refer to Section 2 of this manual for further instructions.
- No one is to operate the Bronco until it has been inspected, serviced, and maintained according to the requirements in this manual.



MODIFICATION OR ALTERATION OF THE BRONCO SHALL BE MADE ONLY WITH PRIOR WRITTEN PERMISSION FROM THE MANUFACTURER.

- Do not operate any Bronco on which the safety decals are missing or illegible.
- Avoid any buildup of debris on the platform floor. Keep mud, oil, grease, and other slippery substances from footwear and the platform floor.

1.2 Bronco Safety Information

- Do not use the Bronco for any purpose other than positioning personnel and their tools, equipment, and materials.
- Never operate a Bronco that is not working properly. If a malfunction occurs, stop use of the Bronco and contact ReechCraft.
- Unless in an emergency, do not allow personnel to tamper with or operate the Bronco from the ground with personnel on the platform.
- The operator will not mount the platform unless the bearing surface is stationary and capable of supporting the intended load.

Fall Hazards

- Before operating the Bronco, make sure the back leg is in the proper position.
 Be sure the platform is properly placed on the all-terrain scaffold unit before mounting.
- Keep both feet firmly positioned on the platform floor at all times. Never use ladders, boxes, steps, planks, or any other item on the platform to provide additional height for greater reach.
- Always use extreme caution when mounting or dismounting the platform.
- Always maintain three points of contact with the Bronco. "Three point contact" means using two hands and one foot or two feet and one hand at all times while mounting or dismounting the platform.

Tipping Hazards

- Be sure the bearing surface is solid, stationary, and capable of supporting the intended load.
- Before mounting the platform, ensure that all locking pins are fully engaged.
- Check the back leg label to ensure the horizontal line is parallel to the ground and the vertical line is plumb.
- Before using the Bronco on floors and other surfaces, check allowable capacity
 of the surfaces.
- Never exceed the maximum platform capacity. Distribute loads evenly on the platform.

Electrocution Hazards

- This all-terrain scaffold is not insulated and will not provide protection from contact or proximity to electrical current.
- Maintain distance from electrical lines, apparatus, or any energized (exposed or insulated) parts according to the Minimum Approach Distance (MAD) as shown in Table 1.0.
- Maintain a clearance of at least 10 ft (3 m) between any part of the all-terrain scaffold and its occupants, their tools, and their equipment from any electrical line or apparatus carrying up to 50,000 volts. For every additional 30,000 volts or less, 1 ft (.3 m) additional clearance is required.
- The minimum safe approach distance may be reduced if insulating barriers are installed to prevent contact, and if the barriers are rated for the voltage of the line being guarded. These barriers shall not be part of (or attached to) the Bronco. The minimum safe approach distance shall be reduced to a distance within the designed working dimensions of the insulating barrier. This determination shall be made by a qualified person in accordance with employer, local, or governmental requirements for work practices near energized equipment.

Table 1.0 - Minimum Approach Distances (MAD)

VOLTAGE RANGE (PHASE TO PHASE)	MINIMUM SAFE APPROACH DISTANCE - FEET (METERS)
0-50 KV	10 ft (3 m)
Over 50 KV to 200 KV	15 ft (5 m)
Over 200 KV to 350 KV	20 ft (6 m)
Over 350 KV to 500 KV	25 ft (8 m)
Over 500 KV to 750 KV	35 ft (11 m)
Over 750 KV to 1000 KV	45 ft (14 m)

Note: This requirement shall apply except where employer, local, or governmental regulations are more stringent.

SECTION 2 PREPARATION + INSPECTION

2.0 Introduction

The Bronco is intended to be used as a personnel handling device and must be operated and maintained by competent personnel only.

Anyone under the influence of drugs or alcohol, or who is subjected to bouts of dizziness, seizures, or loss of physical control must not operate this all-terrain scaffold.

2.1 Operator Requirements

Before operating the Bronco, the operator must read and comprehend this manual.

The operator must be familiar with:

- Use and limitations of the components of the Bronco, including the specification requirements.
- Instruction warning decals on the Bronco and in this manual.
- · Employer and government regulations.
- Use of approved fall protection device (where applicable).
- Sufficient mechanical aptitude and knowledge of the Bronco to recognize a component malfunction or a potential malfunction.
- The safest means to operate the Bronco where overhead and ground hazards are present. These hazards include overhead obstructions, additional moving equipment, obstacles, depressions, drop-offs, etc.
- A means to avoid unprotected electrical conductors.
- The specific job requirements.

Operator Responsibilities

The exercise of good judgment, safety control, and caution in evaluating each situation is the responsibility of the operator. The operator must stop use of the Bronco in the event of a malfunction or other unsafe condition of the all-terrain scaffold or worksite.

2.2 Preparation, Inspection, + Maintenance

Pre-start Inspection

The pre-start inspection should include each of the following:

- Cleanliness Check all surfaces for leakage, debris, or foreign objects.
- Decals Check for cleanliness and legibility. Make sure none of the decals are missing. Make sure all illegible decals are cleaned or replaced. Refer to Section 5.2 for decal contents and locations.
- Safety and Service Make sure a copy of the Operator's Safety Manual is accessible and enclosed in a weather resistant container.
- Setup Make sure the Bronco is set up in accordance with Section 3.1.
- Daily Walk-around Inspection and Function Check Once the walk-around inspection is complete, perform a function check of all systems in an area free of all overhead or ground-level obstructions. Refer to Section 2.3 for additional information.

Table 2.0 outlines the periodic inspection and maintenance recommended by ReechCraft. Consult local regulations for further requirements.

The frequency of inspections and required maintenance must be increased if the Bronco is exposed to harsh conditions, increased use, or if it is used in a severe manner.

Note: Use this manual to perform inspections.

2.3 Daily Walk-around Inspection + Function Check

Begin the daily walk-around inspection starting at item one as noted in Figure 2.0. Continue around the Bronco, checking each item in sequence for the conditions listed in the checklist on page 13.



IFTHE BRONCO DOES NOT OPERATE PROPERLY, STOP USING IT IMMEDIATELY. REPORT THE PROBLEM TO THE PROPER MAINTENANCE PERSONNEL AND DO NOT OPERATE THE BRONCO UNTIL IT HAS BEEN DEEMED SAFE FOR OPERATION.

Note: On all components, make sure there are no loose or missing parts and that everything is securely fastened. Make sure that there is no visible damage or excessive wear.

Walk-around Inspection and Function Check Components

- Locking Pins Check for any debris stuck to or around the locking pins. Make sure the locking pins are working properly and engage freely.
- Spreader Check for bent parts or missing hardware. Make sure the spreader folds out flat and functions properly.
- 3. Rubber Feet Check for cracks or tears.
- 4. Hinge Mount Check all four hinge mount brackets to ensure they are straight.
- TwistLok™ Check for proper function and that locking pins can fully engage the frame clearance holes.

Figure 2.0 - Inspection Points




SECTION 3 OPERATION

3.0 Introduction

Note: The manufacturer has no direct control over the Bronco application and operation. The operator is responsible for following sound safety practices.

The ReechCraft Bronco is an all-terrain scaffold. A removable platform is mounted to a set of Broncos. The all-terrain scaffold is stabilized by way of adjustable legs and locking pins. The Bronco's intended purpose is to provide personnel and their tools access to work areas above the ground.

3.1 **Setting Up the Bronco**

Note: For the purposes of this section, it is assumed that the Bronco is in its fully stowed configuration.

Getting Started

 Unfold the Bronco by pulling out the rear leg and pressing down on the spreader to lock the leg into position.



 Push down on the locking pin, rotate the bottom of the leg, and extend to the desired length. Twist the leg to spring the pin into the hole. Be sure the locking pin is fully engaged.



To ensure proper setup, consult the rear leg decal.



3.2 Weight Distribution

Note the decal on the back leg and ensure that the horizontal line is parallel to the ground and the vertical line is plumb. (See Figure 3.1)

Note: This label is located on the side of the middle leg of the Bronco and must be followed to ensure proper setup.



Note: Do not overload the Bronco. Duty rating is 300 lbs per Bronco.

Figure 5.0 - Fully Retracted Broncos + Platform - Top-down View




Figure 5.1 - Fully Retracted Broncos + Platform





Figure 5.2 - Fully Extended Broncos + Platform

SECTION 6 SERVICE + MAINTENANCE

6.0 Introduction

This section contains general safety precautions that must be observed during maintenance of the Bronco. It is important that maintenance personnel follow these warnings to avoid possible injury to themselves or others. A maintenance program must be established by a competent person and followed to ensure the Bronco is in safe operating condition.

ReechCraft is committed to continuous improvement and reserves the right to make specification changes without prior notification. Contact ReechCraft for updated information.



MODIFICATION OF THE BRONCO WITHOUT THE MANUFACTURER'S APPROVAL IS A PROHIBITED PRACTICE AND A DIRECT SAFETY VIOLATION.



SINCE THE MANUFACTURER HAS NO DIRECT CONTROL OVER THE FIELD SERVICE AND MAINTENANCE OF THE BRONCO, SAFETY IS THE RESPONSIBILITY OF THE OWNER/OPERATOR.

Maintenance Safety

Your safety, and the safety of others, is the primary concern when performing service and maintenance on the Bronco.

- · Remove all rings, watches, and jewelry when performing any maintenance.
- Observe, understand, and obey all danger, warning, caution, and other instructions on the Bronco and in the Operator's Safety Manual.
- Keep standing surfaces and hand holds free of grease, water, oil, etc.
- Use only approved, nonflammable cleaning solvents.
- Always be conscious of moving parts and pinch points.
- · Never leave an object in an unstable or unsupported position.

6.1 Preparation, Inspection, + Maintenance

This section provides the necessary information needed by those personnel that are responsible to place the Bronco in operational readiness and maintain its safe operating condition. To ensure maximum service life and safe operation, be sure that all inspections and maintenance have been completed before placing the Bronco into service.

Preparation, Inspection, and Maintenance

It is important to establish a comprehensive inspection and preventative maintenance program. Table 2.0 outlines the periodic inspection and maintenance recommended by ReechCraft. Consult your local, regional, or national regulations for further requirements.

Note: The frequency of inspections must increase as environment and frequency of use requires.

Pre-start Inspection

It is the operator's responsibility to perform a pre-start inspection of the Bronco prior to use. Refer to Section 2 for pre-start inspection procedures.

This manual must be read and understood in its entirety prior to performing a pre-start inspection.

Frequent and Pre-delivery Inspection

The frequent inspection and pre-delivery inspection shall be performed by a competent person or a qualified mechanic.

The frequent inspection and pre-delivery inspection procedures are performed in the same way but at different times. The pre-delivery inspection shall be performed prior to each sale, lease, or rental delivery. The frequent inspection shall be performed on each all-terrain scaffold in service for three months; out of service for more than three months; or when purchased used. Reference the appropriate areas of this manual for service and maintenance procedures.

Note: The frequency of this inspection must increase as environment and frequency of use requires.

SERVICE + MAINTENANCE

Annual Inspection

The annual inspection must be performed by a competent person or a qualified mechanic on an annual basis, no later than 13 months from the date of the prior annual inspection.

Reference the service and maintenance sections of this manual and appropriate inspection form to complete this inspection.

6.2 Preventive Maintenance + Inspection Schedule

The preventive maintenance and inspection checks are listed and defined in Table 6.0. The table is divided into two parts: "Area" and "Interval". The component or function to be inspected is listed in the "Area" column, and the interval at which time they are to be inspected is listed in the "Interval" column.

Note: The checks and services listed in this schedule are not intended to take the place of any local or regional regulations that may pertain to this type of equipment, nor should the list be considered as comprehensive. Variances in interval times may occur due to the environment the Bronco is subjected to.

Inspection and Maintenance Codes:

- 1. Check for proper and secure installation.
- 2. Ensure there are no visible gouges, excessive wear, or dents.
- 3. Visually inspect for excessive wear, damage, cracks, or distortion.
- 4. Check for cracked or broken welds.
- 5. Ensure worksite is clean and free of debris.
- 6. Check for proper adjustment.
- 7. Check for proper operation.
- 8. Check for proper tolerances.
- 9. Check for proper specifications.
- 10. Verify parts are neither damaged nor missing.
- 11. Perform service and maintenance as necessary.
- 12. Replace any damaged or missing parts.
- 13. Inspect per Operator's Safety Manual.

The following information is provided to assist you in the use and application of service and maintenance procedures contained in this section.



WHEN AN ABNORMAL CONDITION IS NOTED AND PROCEDURES CONTAINED WITHIN THIS MANUAL DO NOT SPECIFICALLY RELATE TO THE NOTED IRREGULARITY, USE OF THE BRONCO SHOULD BE STOPPED AND A QUALIFIED MECHANIC WITH PROPER KNOWLEDGE SHOULD CORRECT THE IRREGULARITY BEFORE WORK IS RESUMED.

Safety and Workmanship

Your safety, and that of others, is the first consideration when engaging in the maintenance of equipment. Always be conscious of moving components and pinch points. Do not allow heavy objects to rest in an unstable position. When raising a portion of the Bronco, ensure that adequate support is provided.

SERVICE + MAINTENANCE

Cleanliness

The single most important item in preserving the long service life of the Bronco is keeping foreign materials out of the vital components. Reasonable precautions have been taken to safeguard against this. However, these areas must be maintained on a scheduled basis in order to preserve proper function of the all-terrain scaffold.

6.4 Decal Replacement

All decals must be mounted to the Bronco as specified and clearly legible.

Note: Refer to Figure 5.3 and Table 5.1 for decal positions and ReechCraft part numbers.

To replace a damaged decal, first remove it completely without damaging the underlying surface. Remove any remaining adhesive with a suitable solvent. Test the solvent on an inconspicuous area first to ensure it does not mark or damage the surface finish.



SURFACE DAMAGE COULD RESULT IN CORROSION AND STRUCTURAL DAMAGE.

- Before applying the new decal, ensure the surface is clean and dry.
- Remove the backing paper, apply the decal along one edge, then seal it gently and evenly.
- If there are any air bubbles, work them gently towards the edge with a clean cloth.
- Pressure sensitive adhesives reach full strength after several days.

All new ReechCraft equipment with serial numbers and date-coded gearboxes (the "product") must be registered at **warranty.reechcraft.com** to activate the product's end-user warranty.

ReechCraft, Inc.'s ("ReechCraft") end-user warranty applies to new product only that is manufactured after September 1, 2018. The end-user warranty is solely for the benefit of the original end user who purchases the product from an authorized reseller of ReechCraft product (the "end user") and is a "manufacturer's" warranty provided directly by ReechCraft to the end user, effective on the end user's original date of purchase. For purposes of this end-user warranty, an authorized reseller of ReechCraft product shall be referred to herein as "reseller." In the event a reseller leases product to a customer of the reseller with or without consideration, the end-user warranty shall apply to the reseller only and NOT to a lessee of the product.

ReechCraft warrants all products for a period of 12 months and all other components and accessories for a period of 90 days from the end user's original date of purchase (the "warranty period"). The end-user warranty is non-transferable by the end user and only applies to product manufactured after September 1, 2018.

During the warranty period, ReechCraft warrants products to be free from defects in materials and workmanship. ReechCraft's obligation and liability on any products that ReechCraft has determined to have been defective in materials or workmanship shall be limited to the repair or replacement of the product, at the sole option of ReechCraft. Such replacement parts shall be provided at no cost to the end user. Replacement parts and components provided under this end-user warranty will continue to be covered until the end of the warranty period. Replacement parts and components purchased by the end user from ReechCraft or a reseller beyond the expiration of the warranty period will carry their own 90-day end-user warranty.

All products purchased by the end user must be registered at warranty.reechcraft.com within 60 days of the end user's purchase for the end-user warranty to be activated. In the event an end user fails to register the product within the 60-day period, this end-user warranty will not apply. ReechCraft reserves the right to request maintenance records of defective parts prior to settling any warranty claim, as well as to deny such claim if maintenance records are not available or not compliant with the product's maintenance schedules. Parts purchased or sourced by suppliers other than ReechCraft or a ReechCraft reseller are not covered under this end-user warranty. Under no circumstances will ReechCraft be responsible for any expense in connection with any repairs using unauthorized parts or in connection with any repairs made by anyone other than a reseller of the product or other ReechCraft authorized service station, unless such repairs have been specified in writing from ReechCraft.
